Please read carefully. By creating an account or using MMOTW (the "Service"), you agree to these Terms.

1. Who we are

MMOTW is provided by EBOX3, established in Andorra. Contact: support@ebox3.com.

2. Eligibility

You must be 18 years or older and capable of forming a binding contract to use the Service.

3. MMOTW is not medical care

MMOTW is a motivational/coaching and well-being tool. It does not provide medical, psychiatric, or psychological advice and is not a substitute for professional care. We do not provide diagnosis, treatment, or guaranteed results, and we avoid 'before/after' claims. If you are in crisis or think you may harm yourself or others, call your local emergency number or crisis hotline immediately.

Platform-compliant marketing: Our marketing and in-app messaging avoid shocking or distressing content, avoid claims of guaranteed outcomes, and avoid depictions that promote negative body image or unsafe behaviors. Promotions must follow the rules of each platform (including TikTok Advertising Policies).

4. Accounts

Provide accurate information, keep your credentials secure, and notify us of unauthorized use. We may suspend or terminate accounts that violate these Terms or our policies.

5. License & acceptable use

We grant you a limited, non-exclusive, non-transferable license to use the Service for personal, non-commercial purposes. You agree not to: misuse, reverse engineer, or attempt to access the source code; upload malware or interfere with the Service; engage in harassment, hate, discrimination, sexual or explicit content, doxxing, or illegal activity; post content depicting minors or identifiable third parties without consent; use the Service to provide clinical diagnoses or treatment; attempt to game ratings or referral rewards; create misleading 'before/after' depictions, exaggerated claims, or content that promotes negative

body image; promote or encourage self-harm or unsafe behaviors; or post affiliate/commission solicitations that violate platform policies (including TikTok's policies).

6. User content & community

You retain rights to content you submit. By posting, you grant EBOX3 a worldwide, royalty-free license to host, reproduce, and display your content for operating the Service. Community posts in MMOTW are anonymous by design; do not include personally identifying details in images or text. We may remove content that violates these Terms or community guidelines.

Body-image sensitivity (TikTok-safe): The Magic Mirror appearance insights feature is optional, for entertainment and motivational purposes only. We prohibit shaming, harassment, or degrading comparisons; no 'before/after' depictions, diet/weight-loss claims, or statements implying an ideal/standard of beauty. Users must follow our guidelines; violations may lead to removal or suspension. You can hide or delete your posted image at any time.

7. AI features

AI outputs may be inaccurate or inappropriate. You are responsible for how you use them. We filter and rephrase community comments to reduce harassment, but we cannot guarantee all harmful content will be prevented. AI appearance analysis does not perform facial recognition or identity verification and does not create biometric templates.

8. Plans, pricing & payment

Free Plan: €/ \$0 per month with core features.

Premium Plan: €/ \$4.99 per month, billed annually (€/ \$59.88). Prices include applicable taxes where required. Subscriptions auto-renew unless canceled before renewal. Access continues until the end of the paid term. We may change prices with prior notice and an option to cancel before changes take effect.

9. Refunds

Where required by law, you may have a withdrawal/cooling-off right for online purchases. Otherwise, fees are non-refundable except where we choose to provide goodwill refunds.

10. Referral program

Users may earn €/ \$10 only when a referred user purchases a Premium annual (yearly) subscription (billed €/ \$59.88 per year) using your unique referral link/code, subject to: the referred user must be new to MMOTW and complete the annual purchase; monthly subscriptions do not qualify; reward is issued once per referred account after any applicable trial/cooling-off period and payment clearance; no self-referrals, duplicate accounts, coupon/offer stacking, or incentivized/paid traffic that violates platform rules; no multi-level marketing or recruitment chains; do not make earnings or income claims; payout method, minimum thresholds, and any KYC/Tax requirements may apply; we may withhold or reverse rewards for fraud, chargebacks, cancellations, or policy violations; we may modify or end the referral program at any time.

11. Intellectual property

The Service, including logos, UI, and content, is owned by EBOX3 or its licensors. You may not use our marks without prior written permission.

11A. Advertising & platform policies (TikTok-safe)

When promoting MMOTW on third-party platforms (including TikTok): do not make medical/clinical claims, guaranteed-results claims, or depict self-harm, crisis, or shocking content; do not use 'before/after' imagery or negative body-image messaging; avoid idealized beauty standards; do not make earnings/income claims about the referral program; ensure landing pages clearly display Contact, Privacy, Terms, pricing, and an 18+ audience statement, and use only functional cookies; all ads must be truthful, accurate, and consistent with these Terms and the platform's advertising policies. We may remove content or terminate campaigns that violate platform rules.

12. Disclaimers & limitation of liability

The Service is provided 'as is' and 'as available'. To the maximum extent permitted by law, we disclaim warranties and limit liability for indirect, incidental, or consequential damages. Nothing in these Terms excludes liability that cannot be excluded by law.

13. Indemnity

You agree to indemnify and hold EBOX3 harmless from claims arising out of your use of the Service or your breach of these Terms.

14. Termination

You may stop using the Service at any time. We may suspend or terminate access for violations or risks to users or the Service. Upon termination, certain provisions survive (e.g., IP, disclaimers, liability limits).

15. Governing law & disputes

These Terms are governed by the laws of Andorra, without regard to conflict of laws. Courts located in Andorra shall have exclusive jurisdiction, unless mandatory consumer protection rules provide otherwise.

16. Changes to Terms

We may update these Terms. We will post the new version with a new 'Last updated' date and, where required, notify you. Continued use means you accept the changes.
